Need of a user-friendly IMS Scoring Software

Revise the scratch boat for PLS

This submission was accepted last year but was not programmed in the software. It is now (on the conference) done. DSV 1 was therefore considered outdated.

FIV 7

Additional ORC-Representative on Green-Book-Events.

After a intensive discussion about probable mistakes of an event organizer, the committee was not sure these problems can be avoided by another ORC Representative, who óin our understanding- would not have the power to decide matters against the organizer.

ORC should understand itself as a service-organization and should offer its support, wherever a lack of experience is discovered.

RMS is recommending a less mandatory wording of the proposed modification to Par.5.2 of the Green Book:

Time Limit for the Offshore Race Green-Book-Events.

RMS wishes to support a regulation about time limit, but could not come to a common meaning about how this should be executed. There is a tendency towards an individual time limit for each yacht.
